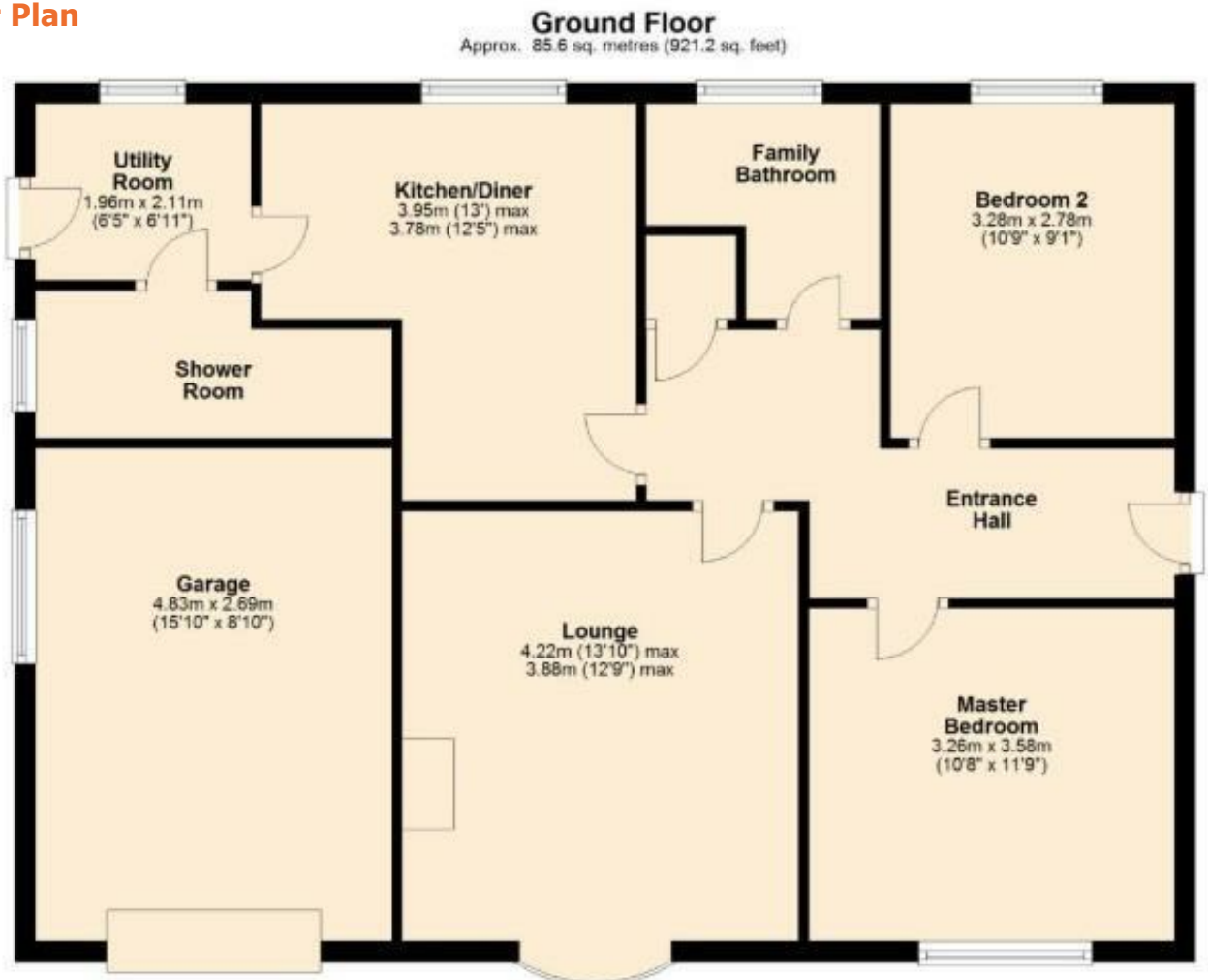

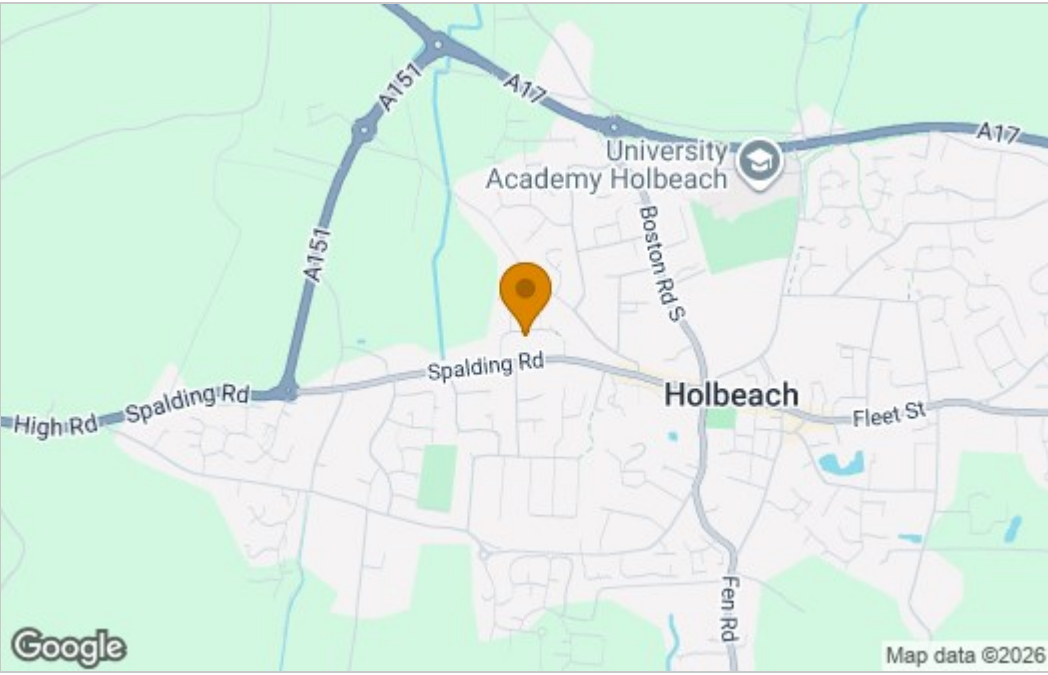

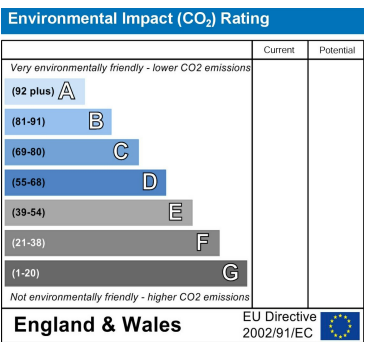
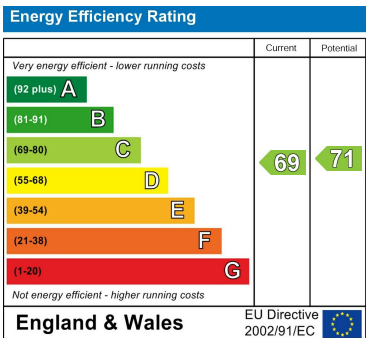
Floor Plan
